Attorney/Senior Partner, Barber Banaszynski. Admitted to the Kentucky Bar in September of 1968, Mr. Barber has a general litigation and corporate practice. He also represents client interests in civil, criminal, Constitutional and legislative matters. Achievements include serving as lead counsel for Kendrick v. Bland, brought on behalf of a class of prisoners against the Commonwealth of Kentucky, resulting in a \$232 million settlement. In a 1998 action against the Spencer County (Ky.) Public School District, Mr. Barber convinced a federal court that students had been harassed by other students without protection by school personnel. The case was tried to verdict, resulting in a \$220,000 judgment against the school district. It is one of the first cases in which a plaintiff proved that school officials acted with deliberate indifference, a standard established by the U.S. Supreme Court in June 1998.
